

GENERAL TERMS AND CONDITON OF SALE

All conditions are binding for both parties. Any modification requires notification in writing and will get confirmed by NEUROSPEC AG.

OFFERS MADE

All products that are included in this list are not binding, only after an order has been submitted to NEUROSPEC AG who then confirms the receipt of the order. Special offers, or price differences for similar or same items on websites, catalog etc. from manufacturer's we represent or not represent, are not applicable, comparable, as other cost factors (import costs, duties or handling fees by freight companies) influence our pricing structure. None of the products in this Accessories Pricelist include GST/VAT/TVA/IVA (for Exports we do not charge the local GST/VAT/TVA/IVA however GST/VAT/TVA/IVA and possibly some importation costs will be charged by DHL, or FEDEX before delivery and on location) - we will add freight charges.

ORDERS PLACED

NEUROSPEC AG has the right to neglect an order without any reasons given, especially where a financial risk may occur to NEUROSPEC AG. If an order is cancelled after it has been placed with us, we may charge 20% cancellation fee / or re-stocking fee (if parts have been ordered by the time a cancellation has been received). Once NEUROSPEC AG confirms an order, the order is committed and will be sent to you as soon as parts are available.

DELIVERY

Many products can normally be delivered from stock. We would normally aim to deliver all parts in one single shipment, although we can also back-order parts that may not be accessible for some time to avoid un-necessary delays.

*** Freight charges are based on a total weight of 4kg's - should the consignment be less heavy, we will then reduce the freight on the invoice to the actual cost. Should you wish to use your own shipper and be charged by them, then state this on the order form and supply your account details along with your order!

PAYMENT TERMS

Unless otherwise stated, payment will be made before we deliver the goods. Standard procedure would be that we will order the goods from either suppliers or manufacturers as soon as the full payment has been booked into our account (see below details for complete bank wire transfer details). If terms have been negotiated, however payments are made late, then NEUROSPEC AG has the right to charge interest which will be depending on current bank interest rates (for future orders, we will determine whether we will cancel any previous agreement on payment after delivery). Late payments will incur a charge plus interest. We will calculate and add the due fees on the next order/invoice made.

RETURNS AND CLAIMS

Before returning any item, please call for a return material authorization (RMA) within 7 days from date of delivery. Authorized returns may be subject to a restocking fee of 20% of the sales price of the item. Items must be returned in their original condition, clean and undamaged, to qualify for credit.

Please ship any returned items prepaid, with a copy of the original invoice and return authorization form, issued by NEUROSPEC AG, citing the circumstance causing the return. Your account will be credited for the purchase price of the merchandise, less any restocking charges and original freight costs. NEUROSPEC AG will not accept returns on custom items. All accessories are warranted up to 90 days (some items are warranted up to 12 months).
